1. CAUSE OF ACTION - "TRESPASS"

- A.** The Defendants have trespassed onto the Constitutional Property of the Plaintiff in that the Plaintiff, a Registered Elector by virtue of Section 9 to 128 of The Commonwealth Constitution, is a subject of The Monarch of the United Kingdom and by such inherent right does owe an allegiance to such Monarch until altered or amended by a valid Referendum.
The Defendants have trespassed on this right.
- B.** The trespass was activated by the criminal enactment of legislation created and **enacted within Australia on 1 January 2004.**
- C.** The title of the Legislation –
"Acts Amendment and Repeal Courts and Legal Practice Act".
- D.** The Commonwealth of Australia was included into the Legislation thereby compounding the trespass throughout Australia.
- E.** The Trespass has created damage to the Plaintiff.

2. CAUSE OF ACTION - "BANKRUPTCY"

- A.** The Defendants have concealed the material fact from the Plaintiff and all electors that fact being the bankruptcy of the Mandated Territory of Australia in the period 1943-1945.
- B.** In this period at San Francisco (1943) the United Nations was birthed. By 1945 The United Nations had formulated The United Nations Charter with five permanent Member States.
- C.** Russia, China, France, United States of America and The United Kingdom. This last Nation founded Australia.
- D.** The United Nations immediately bankrupted all Mandated Territories inclusive of Australia in 1945 and became the Trustee in Bankruptcy over the mandated Territory of Australia.
- E.** This material fact has been concealed by the Defendants.
- F.** By concealing this fact, the Defendants have caused damage to the Plaintiff.

3. CAUSE OF ACTION - "FRAUD"

- A. The element for fraud is the concealment of a material fact.
- B. In the year 1948 The Commonwealth Parliament in written agreement with The United Nations created the Act

"Nationality and Citizenship Act"

for the purpose of placing the United Nations into a Law of The Commonwealth of Australia in the Section **"Trust Property"**.

- C. The United Nations is **"The Trustee"** in bankruptcy over the land and people of Australia meaning in Law that they own the lot.
- D. **FRAUD VITIATES EVERYTHING.**
- E. The concealment of this fact has caused damage to the Plaintiff.

4. CAUSE OF ACTION - "CONSTITUTIONAL CONFLICT"

- A. The Defendants have not identified The Constitutional conflict in that we have a written Constitution under a Constitutional Monarch, but, at the same time, since 1945 a **"Trustee in Bankruptcy"** up to and inclusive of this Treason date, the 1 January 2004.
- B. The concealment of this fact has caused damage to the Plaintiff.

5. CAUSE OF ACTION - "ATTAINED OF TREASON"

- A. In the period 2002 to 2004 a Federated State (1901) Western Australia introduced legislation into their State Parliament with the intention of:

Removing The Crown
Removing The Monarch
Removing The Oath of Allegiance

- B. The Act is Titled: (enacted 1 January 2004)

"Acts Amendment and Repeal Courts and Legal Practice Act"

- C. The concealment of this fact has caused damage to the Plaintiff.

6. CAUSE OF ACTION - "THE COMMONWEALTH"

- A. The Plaintiff states that the **"Act"** did include **"The Commonwealth"** into the actual Act, without any Commonwealth Act permitting the inclusion of **"The Commonwealth" into the Western Australian Act and as such "Fractured Federation"**.

B. The concealment of this fact has caused damage to the Plaintiff.

7. CAUSE OF ACTION - "THE GOVERNORS"

A. The Plaintiff states that the Enactment was signed by two men:

John Sanderson - Governor

James McGinty - Attorney General

In their respective public office capacity.

B. The involvement of a State Governor (WA) brings all State Governors into the attack upon the people of Australia. (Misprison of Treason)

C. The involvement of an Attorney General implicates all Attorney Generals.

D. The concealment of this fact has caused damage to the Plaintiff.

8. CAUSE OF ACTION - "THE SENATE"

A. Within the Commonwealth Constitution "**Sections 7 to Section 23**" outline the Constitutional obligations relating to the Senate and Senators.

B. **Section 12** creates the problem relating to and involving State Governors and the issue of Writs for State Senators.

C. The obligation under **Section 12** is affected by the removal of **The Crown and Monarch by a State Governor activated on 1 January 2004**.

D. The Plaintiff states that since the date of 1 January 2004 no State Governor has issued a valid Constitutional Senate Writ.

E. The concealment of this fact has caused damage to the Plaintiff.

9. CAUSE OF ACTION - "QUALIFICATION"

A. The Plaintiff states that "**Section 8**" of The Commonwealth Constitution (Qualification of Electors) has been nullified after 1 January 2004 –

That is, no Elector is qualified because of -

The Removal of The Crown

The Removal of The Monarch

The Removal of The Oath of Allegiance

B. The concealment of this fact has caused damage to the Plaintiff.

10. CAUSE OF ACTION - "DISQUALIFICATION – FIRST DEFENDANT"

- A.** The Plaintiff states that **"Section 44"** of The Commonwealth Constitution is the disqualification section.
- B.** The **First Defendant** cannot legally accept nominations for Senators under Form 59 **after the removal of The Crown. (1 January 2004)**
- C.** The removal of The Crown disqualifies every Elector.
- D.** **"Section 44 (ii)"** attainted of Treason, activates the criminal offence of Treason, **in addition, the concealment of such treason.**
- E.** The criminal element for Treason is **"Breach of Allegiance"**
- F.** **The Authority Case is R v Casement 1917 KB at 114**
- G.** The concealment of this fact has caused damage to the Plaintiff.

11. CAUSE OF ACTION - "THE AGENDA"

- A.** The Plaintiff states that this overt act of Treason involved
 - a) The United Nations**
 - b) International Freemasonry**
 - c) Political Parties in Australia**
 - d) The Fabian Society or International Fabian Socialists**
 - e) Judicial concealment within Australia**
 - f) Fraud by every Senator since 1 January 2004.**
- B.** The concealment of this fact has caused damage to the Plaintiff.

12. CAUSE OF ACTION - "THE EVIDENCE"

Two Acts provide the evidence in this Litigation:

- A. "Nationality and Citizenship Act" (1948)**
- B. "Acts Amendment and Repeal Courts and Legal Practice Act" 1 January 2004.**
- C.** The concealment of this fact has caused damage to the Plaintiff.

13. CAUSE OF ACTION - "THE BANKS AND SENATORS"

A. The Bail In Legislation

"Financial Sector Legislation Amendment (Crisis Resolution Powers and Other Measures Act" 2018.

B. This alleged legislation is void in Law because of the fact evidenced by Hansard's that the Senate Quorum was not complete.

C In addition no Senator could assume a valid seat because of the removal of **The Crown (2004) activating Section 44.**

D. **Commonwealth Constitution Section 44 states**

"Incapable of sitting or of being chosen".

E. The concealment of this fact has caused damage to the Plaintiff.

14. CAUSE OF ACTION - "FEDERAL POLICE"

A. **Crimes Act 1914 (CTH) Section 3AA** defines a **"Constitutional Corporation"** revealed in **Section 51 (20)**

"Foreign Corporations, and trading or Financial Corporations formed within the limits of The Commonwealth".

B. The Section in the Crimes Act is the sole responsibility of the Australian Federal Police to action the involvement of the Senate in creating legislation **to asset strip Australian Bank Accounts and to transfer such assets to the Secured Party, The New York Branch of the Federal Reserve.**

C. The concealment of this fact has caused damage to the Plaintiff.

15. CAUSE OF ACTION - "BIRTH CERTIFICATES"

A. Because of the creation of the **"International Trustee"** over Australia Australian Birth Certificates are part of the collateral obtained by **"The Trustee"** and as such allegedly permits **"The Trustee"** to obtain Australian Birth Certificates, convert them to **"CUSIP Numbers"** then to trade the CUSIP Numbers (the babies) after which the CUSIP Numbers are repeatedly traded onto 21 Stock Exchanges around the world for monetary value.

B. This is Human Trafficking not revealed by the Defendants.

C. The concealment of this fact has caused damage to the Plaintiff.

16. CAUSE OF ACTION - "TO BE KILLED"

- A. This particular cause of action reveals the intention of this Satanic agenda currently being played out within Australia.
- B. The Satanic intention is to mark every Australian, those who resist or refuse **"should be killed"**.
- C. 6,770,000 Victorians need to know this intention before it is too late
- D. **Revelation 13:15 "Should Be Killed"**

18. CAUSE OF ACTION - "THE 6 SECTIONS"

A. The Constitution of the State of Western Australia has 6 Sections protected by Referendum Consent.

- B. The six are: 2 3 4 50 51 73
- Section 2(3) Subject to Section 73
- Section 3 State Governor and Parliament
- Section 4 Session Per Year
- Section 50 Office of Governor
Subject to Section 73 (2)
- Section 51 "Royal Sign Manual"
- Section 73(2) Subject to the Elector (2, 3, 4, 50, 51, 73)

19. CAUSE OF ACTION - "AUSTRALIA ACT 1986"

- A. At Section 14 of The Australia Act in 1986 Sections 50 and 51 (WA) were included, but, these two Sections are two of the Six Sections protected by State Referendum Requirements at Section 73 (2).
- B. No Referendum called or conducted.
- C. The concealment of this fact has caused damage to the Plaintiff

20. CAUSE OF ACTION - "SECTION 106"

- A. Commonwealth Constitution
Section 106 – Saving of Constitution
"until altered in accordance with the Constitution of the State"
- B. This did not occur in relation to Western Australia.
- C. The concealment of this fact has caused damage to the Plaintiff

21. CAUSE OF ACTION - "SECTION 6"

- A. Section 6 of Australia Act 1986 **invalidates any legislation omitting "manner and form" that is, requiring a Referendum.**
- B. The concealment of this fact has caused damage to the Plaintiff

22. CAUSE OF ACTION - "SECTION 5"

- A. Operation of the Constitution and Laws
Section 5 is the UK portion:
"This Section binds the Courts, Judges and People of every State".
- B. This Law has been disregarded by Courts and Judges.

C. The concealment of this fact has caused damage to the Plaintiff

23. CAUSE OF ACTION - "DEFINITION"

- A. In the Definition Section of The Commonwealth Constitution "**The Commonwealth**" shall mean "**the Commonwealth of Australia as established under this Act**".
- B. **Acts Amendment and Repeal Courts and Legal Practice Act 2003 (WA) Section 123 The Criminal Code(5) deletes "Crown", inserts "State" or "The Commonwealth".**
- C. The insertion of "**The Commonwealth**" involves the whole of Australia and the people of Australia in an attack upon themselves.
- D. The concealment of this fact has caused damage to the Plaintiff

24. CAUSE OF ACTION - "THE PREAMBLE"

- A. Contained within the Preamble of the Commonwealth Constitution is the fact that the Constitution was created under "**The Crown**"
- B. But, they criminally removed "**The Crown**"
- C. The concealment of this fact has caused damage to the Plaintiff

25. CAUSE OF ACTION - "VEXATIOUS LITIGANT"

- A. "**Acts Amendment and Repeal Courts and Legal Practice Act**" at Section 130 amends the Supreme Court Act of Western Australia and as such implicates every officer of the Supreme Court of Western Australia in Treason.
- B. Because of the inclusion of "**The Commonwealth**" into the Act, every officer of every Supreme Court within "**The Commonwealth**" is a Principal Offender to Treason compounded by concealment.
- C. The Criminal Penalty for committing Treason or concealing Treason is Life Imprisonment.
- D. The Supreme Court of Western Australia made the Plaintiff a Vexatious Litigant to conceal the facts identified in this litigation.
- E. The Supreme Court of Victoria made the Plaintiff a Vexatious Litigant to conceal the facts identified in this litigation.
- F. The concealment of this fact has caused damage to the Plaintiff.

26. CAUSE OF ACTION - "SHIRE COUNCILS"

- A.** The Defendants in this action, the State Senators, have failed to reveal the fact that the Shire Councils functioning within Victoria are under the control and supervision of **"The Trustee"**, meaning they are not subject to the voting electorate.
- B.** **"The Trustee"** is about to introduce drastic changes to Local Government.
- C.** The Defendants in this action (all 13 of them) have not revealed the intent of **"The Trustee"** to the people of Victoria.
- D.** The concealment of this fact has caused damage to the Plaintiff.

27. CAUSE OF ACTION - "ATTORNEY-GENERALS"

- A.** Since 1 January 2004 all Attorney-Generals have primary and principal knowledge of the organised attack launched upon the people, but, have refused to act to protect the people of the various States and Commonwealth.
- B.** The current nine Attorney-Generals are,

- C.** It is written into Law that all Attorney-Generals must be notified whenever a Constitutional issue comes before any Court.
This is set out at **Section 78B of the Judiciary Act 1903 (CTH)**
- D.** Even with knowledge they will not act because of **"The Trustee"**.
- E.** The concealment of this fact has caused damage to the Plaintiff.

28. CAUSE OF ACTION - "HIGH COURT JUDGES"

- A.** The current seven High Court Judges are,

 - 2. Justice Michelle Marjorie Gordon AC**
 - 3. Justice James Joshua Edelman**
 - 4. Justice Simon Harry Peter Steward**
 - 5. Justice Jaqueline Sarah Gleeson**

 - 7. Justice Robert Thomas Beech-Jones**
- B.** Since 1 January 2004 no Judge or Magistrate can preside over any matter, because they cannot be a **Chapter 3 Court**, after the removal of The Crown, The Monarch and Oath of Allegiance.
- C.** They are unindicted co-conspirators operating with **intent to deceive** the people of "**The Commonwealth**".
- D.** The concealment of this fact has caused damage to the Plaintiff.

29. CAUSE OF ACTION - "SCRIPTURE ASPECT"

- A. Micah 7:10**
- Scripture is added to counter the female Statue of Justice above the Victorian Supreme Court.

SHE THAT IS MINE ENEMY

Then she that is mine enemy shall see it, and shame shall cover her which said unto me, Where is the LORD thy God? mine eyes shall behold her: now shall she be trodden down as the mire of the streets.

B. Proverbs 7:24-27

THE FEMALE - THE SPIRITUAL OPPONENT

30. **CAUSE OF ACTION - "SECTION 128"**

- A. The Commonwealth Constitution states at Section 128 that the Constitution shall not be altered except in the following manner:
- B. Section 128 was not abided by when **The Crown** was removed.
- C. Section 128 was not abided by when **The Monarch** was removed.
- D. Section 128 was not abided by when the **Statutory Oath of Allegiance** was removed.
- E. The concealment of this fact has caused damage to the Plaintiff.

31. **CAUSE OF ACTION - "REDCREST" or "PRACTICE COURT"**

- A. Today within the Victorian Supreme Court documents must be lodged into a computer called "Redcrest". This is Virtual Reality.

THE ALTERNATIVE

It is possible if an objection is made concerning "**Redcrest**", to lodge documents into the "**Practice Court**" of the Victorian Supreme Court but, Court staff do not permit this.

32. CAUSE OF ACTION "TWO SPIRITUAL LAWS"

- A.** The Plaintiff states that in the New Testament **two Spiritual Laws** are revealed, one set represents Jesus Christ, the other set represents sin and death sin is revealed in Zechariah 5.
- B.** This Litigation reveals both sets.
- C. Romans 8.2 "True Freedom"**
"For the Law of the Spirit of Life in Christ Jesus has made me free from the law of sin and death."
- D.** The Defendants in this Litigation work in the **second Spiritual Law.**
- E.** The concealment of this fact has caused damage to the Plaintiff.

33. CAUSE OF ACTION "FREEMASONRY"

- A.** Freemasonry is the spiritual religion of **Pharaoh and Egypt.** The second set of Spiritual Law
- B.** Membership in the Egyptian religion activates the curses that Almighty God placed on Pharaoh and his army of followers.
- C. Freemasonry is the controlling factor controlling the Victorian Supreme Court and as such Victoria.**
- D.** The spiritual marriage of King Solomon of Israel and Pharaoh's daughter is evident today. **(1 Kings 3:1)** In particular, what is happening today in Israel.
- E.** The concealment of this material fact has caused damage to the Plaintiff.

34. CAUSE OF ACTION - "PHARAOH"

- A.** The Plaintiff herein sets out a few Scriptures exposing **"Pharaoh"** in the light of Scripture.
- B.** Pharaoh is not Lucifer and Lucifer is not Pharaoh. Pharaoh outranks Lucifer.
- C.** This is Pharaoh - **"Trees of Eden"**
"In the Garden of Eden"

Ezekiel 31:18

"To whom art thou thus life in Glory and in greatness among the trees of Eden. Yet shall thou be brought down with the "Trees of Eden" unto the nether parts of the earth, thou shalt lie in the midst of the uncircumcised **with them that be slain** with the sword."

"This is Pharaoh"

And all his multitude, saith the Lord God"

- D.** The Great Dragon "Pharaoh"

Ezekiel 29:3

"Speak and say, thus saith the Lord God, behold I am against thee, Pharaoh King of Egypt,

"The Great Dragon"

That lies in the midst of his rivers, which hath said, My river is mine own, and I have made it for myself".

Comment: "This Scripture will be repeated again in this Litigation" because of the effect in the Book of Revelation, currently being played out in Israel today, in particular Chapter 12 in the Book of Revelation.

E. Pharaoh out of Hell

Romans 9:17 - To be the male opponent

"For the Scripture saith unto Pharaoh, even for this same purpose have I raised thee up, that I might shew My power in thee, and that My name might be declared throughout all the Earth"

COMMENT: Ezekiel Chapter 31 and 29:3 (Ezekiel).

35. CAUSE OF ACTION - "PHARAOH AND SOLOMON"

A. King Solomon of Israel –

This name opens every Masonic Lodge in Australia today, but, Masons are unaware that it connects directly to Pharaoh, because of the forbidden marriage. (Egypt with Israel).

B. 1 Kings 3.1 - "The Marriage"

"And Solomon made affinity with Pharaoh King of Egypt, and took "Pharaoh's daughter" and brought her into the City of David, until he had made an end of building his own house, and the House of The Lord, and the Wall of Jerusalem round about".

COMMENT: Pharaoh's daughter still resides in the City of David today because the people of Israel are ignorant of this forbidden marriage and it is causing chaos "on both sides of the current war."

- A. I came from a Catholic background so I am familiar with this comment. **"Catholics are ignorant of Scripture and the history of the separation created by the trial of Martin Luther (The Reformation) and the banning of The Vatican City, Knights of St John of Jerusalem, from England in 1540, in addition to the reasons behind the Trial of the 7 Bishops 1688 and The Enactment of the Act of Settlement 1701."**
- B. Many years back a lady said to myself **"You are a Catholic Charismatic"** which I was, she then said **"Can you say that Jesus Christ is Lord"**, I then said this, she then said **"Yes, you are Born Again"**. (I had never heard this until then)
- C. **John 3:3-7 - "You must be born again"**

- D. In relation to Catholics this particular Scripture is not known by the Catholics. I only heard it when the lady spoke it out.
- E. I mention this in this Litigation because millions of Catholics are unaware and unprepared for what is coming, similar to the people in Israel thinking that the paragliders were doing a training exercise until the shooting began at the Buddha Festival.
- F. The Defendants in this action are in a similar **Spiritual illusion** to the Catholics of Victoria.
- G. The concealment of this fact has caused damage to the Plaintiff.

- A.** Officers of the Victorian Supreme Court since 1 January 2004 are repeatedly and regularly committing this serious indictable offence with impunity, in very simple terms "they" do not give a hoot about committing this offence.
- B.** **This particular offence is the concealment of the offence of Treason. This carries Life Imprisonment.**
- C.** The offence of Treason happened when a Federated State, that is Western Australia, created a Bill moving the Bill through their State Parliament and on 1 January 2004 enacted the Bill into an Act.
- D.** **The Act is titled**
"Acts Amendment and Repeal Courts and Legal Practice Act".
- E.** **The Act is Ultra Vires and in total conflict with the superior Act, The Commonwealth Constitution.**
- F.** The Bill/Act included

"The Commonwealth"

into the Western Australia Legislation, without any legislation from the Parliament of The Commonwealth consenting to the inclusion, in simple terms, West Australians just included "The Commonwealth" thereby involving every Australian in an overt act of Treason and the concealment of such act activating "Misprison of Treason".

- G. The purpose of this legal action is to expose the actual Act and the legal and Constitutional consequences coming on the people of the various States and Territories with Spiritual consequences.

40. CAUSE OF ACTION - "The Supreme Court and Redcrest"

- A. Staff at the Victorian Supreme Court Registry **"The Prothonotary"** absolutely ignore the serious indictable offences revealed and demand that all paperwork be filed via their computer, **"RedCrest"**.
- B. **"RedCrest"** is a computer, this computer allegedly protects actual staff with a pulse from being criminally charged by Private Prosecution via the Magistrates Court of Victoria for concealing the evident treason.

41. CAUSE OF ACTION - "LISA HANNAH"

- A. This particular lady used to be a Judge in the County Court, in that capacity in the year 2010, had full knowledge of the overt act of Treason created 1 January 2004 out of Western Australia.
- B. Today Lisa Hannah is the Chief Magistrate of The Victorian Magistrates Court. Switched with Peter Lauritsen, the Former Chief Magistrate.
- C. **Lisa Hannah's principle and primary job with her Court staff is to block any and all Private Prosecutions coming into any Magistrates Court "before" the committal process even begins.**

42. CAUSE OF ACTION - "GEOFFREY NETTLE" 6890-1999

- A. **In the year 2005 this man, a Judge of The Victorian Supreme Court, sitting with the then President of The Court of Appeal, Chris Maxwell, concealed and blocked 13 Grand Jury Applications that had been lodged with The Victorian Supreme Court.**
- B. In the year 2008, this man sitting with another **Supreme Court Judge, Dodds-Streeton**, did the same thing that he did in the year 2005.
- C. Geoffrey Nettle, Chris Maxwell and Dodds-Streeton did conceal an overt Act of Treason,

- D. By such conduct two twin Criminal Offences occurred

- a) **TREASON - "LIFE IMPRISONMENT"**

SECTION 44 states –

Disqualification.

Any person who--

- (i.) Is under any acknowledgment of allegiance, obedience, or adherence to a foreign power, or is a subject or a citizen or entitled to the rights or privileges of a subject or a citizen of a foreign power: or
- (ii.) Is attainted of treason, or has been convicted and is under sentence, or subject to be sentenced, for any offence punishable under the law of the Commonwealth or of a State by imprisonment for one year or longer: or
- (iii.) Is an undischarged bankrupt or insolvent: or
- (iv.) Holds any office of profit under the Crown, or any pension payable during the pleasure of the Crown out of any of the revenues of the Commonwealth: or
- (v.) Has any direct or indirect pecuniary interest in any agreement with the Public Service of the Commonwealth otherwise than as a member and in common with the other members of an incorporated company consisting of more than twenty-five persons:

shall be incapable of being chosen or of sitting as a senator or a member of the House of Representatives.

But sub-section iv. does not apply to the office of any of the Queen's Ministers of State for the Commonwealth, or of any of the Queen's Ministers for a State, or to the receipt of pay, half-pay, or a pension by any person as an officer or member of the Queen's navy or army, or to the receipt of pay as an officer or member of the naval or military forces of the Commonwealth by any person whose services are not wholly employed by the Commonwealth.

62. COMMONWEALTH CONSTITUTION

SECTION 80 – states

Trial By Jury

The trial on indictment of any offence against any law of the Commonwealth shall be by jury, and every such trial shall be held in the State where the offence was committed, and if the offence was not committed within any State the trial shall be held at such place or places as the Parliament prescribes.
