**NOTICE FOR FURTHER AND BETTER PARTICULARS**

Dear Sir/ Madam

I have a right under the Imperials Acts Application Act, a law of the States, to be presumed innocent until proven guilty. Your request for payment/ tax in this matter is a clear breach of that right and I am aggrieved by your unlawful attempt to tax a payment from me when I have committed no criminal offence, offended/ broken no law and caused no personal harm to any resident.

This letter is to serve as my written notification that I formally object to the penalty notice number 1664348290 as I have done nothing wrong. I was out of the country from 1st of June 2022 till 4th September 2022 during the time when the alleged offence occurred.

I request that Revenue NSW provide PROOF that the "Appropriate approved traffic enforcement device" is approved and under what authority? Revenue NSW, Australian Business Number 81 913 830 179, is also required to provide the proclamation date and certificate of assent of the particular law and which particular law it is that I am accused of offending? I will require certification that this law has in fact been lawfully enacted by the Parliament of NSW in the Queen's name, as it is required to be, subject to the Commonwealth of Australia Constitution Act 1900 (UK) which was approved again as a result of the 6 November 1999 Referendum.

I am seeking certification that the photograph that was allegedly produced from the device on this day could not have been tampered with or altered in any way and I require proof of security measures, algorithms and metrology used to ensure this process is completely secure and could not have been mathematically broken, cracked or hacked.

As I am a British subject and not an Australian Citizen, as defined in the Imperial Acts Application Act, a law of the Commonwealth, I have a right to be presumed innocent until proven guilty.

Revenue NSW and NSW Government shall produce proof of claim within 28 days upon receipt hereof with the affidavit and attached supporting documentation as aforementioned, or Revenue NSW shall:

1. Admit and agree that no such documentation can be produced by Revenue NSW
2. Admit and agree that Revenue NSW are bound undercover clause 5 of the Commonwealth of Australia Constitution Act 1900 UK; and
3. Agree that where there is an inconsistency between the law of the Commonwealth and a law of the State, the law of the Commonwealth shall prevail and the law of the State shall be invalid to the extent of the inconsistency as set out in Section 109 of the Commonwealth Constitution Act 1900 UK; and
4. Agree that Revenue NSW and NSW Government knowing, willfully and intentionally failed to present proof of claim within the time specified and allotted herein; and
5. Agree that the conditions required in this Notice of Objection are not frivolous and vexatious; and,
6. Agree to be prohibited from the unlawful action based on a mobile phone camera reading against Richard James by the way of any penalty or any lawsuit or any procedure for taking or confiscation or allocating demerit points in relation to a driver's licence, which may occur as a result of this alleged penalty notice; and
7. Agree to be prohibited from taking unlawful action based on a law that has not been correctly enacted against Richard James by way of any penalty of any lawsuit or any procedure for taking confiscation or allocating demerit points in relation to a driver's licence, which may occur as a result of this alleged penalty notice; and
8. Agree that no officer or representative of Revenue NSW or NSW Police may attempt to perform any act that is unlawful, or falsely represents its true intention and that they and NSW Police are acting in full accord with the laws of the Commonwealth and the laws of Her Majesty the Queen in the State of NSW and,
9. Agree that any such attempt may constitute a breach of Section 43 of the Crimes Act 1914 \*Cth); and,
10. Agree that Richard James has and retains the right to claim damages as a result of any adverse or harmful effects upon him brought about by the action of Revenue NSW and NSW Government and / or it's officers; and
11. Agree that this constitutes that Revenue NSW and NSW Government may reject this consensual agreement by way of providing the requested sworn affidavit and attached supporting documentation within the time stipulated in this agreement and in no other written or verbal manner.

If Revenue NSW and NSW Government agree to the aforementioned terms and conditions of agreement and contract, then simply do nothing within the specified time for response or answer the above points incompletely.

As I wish to remedy this matter as soon as possible and there is in fact a debt owing I would sincerely like to have this matter finalised. If you wish me to remain trustee of the name presented in your notices, there will be a compensation charge of \$500 000 if you Revenue NSW and NSW Government have not responded in 28 days I, Richard James: McDonald will assume the debt exists and I will defalk the sum of \$352 from the \$500 000 compensation charge bearing a total of \$499 648.

I was not aware of the UNIDROIT treaty of Rome 1973 signed by Gough Whitlam **MP** AUSTRALIAN GOVERNMENT which places my sovereign account in danger.

I reserve my right not to be compelled to perform under any contract or commercial agreement that I did not enter knowingly, voluntarily and intentionally. I do not accept the liability of any compelled benefit or any unrevealed contract or commercial agreement.
